

ARTICLES OF INCORPORATION

OF

RENEM. DELOMBARD, P.A.

The undersigned individual, licensed to practice the profession of law in the State of Florida, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Chapter 607, Florida General Corporation Act, and Chapter 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Preficiency of Incorporation:

ARTICLE I NAME OF CORPORATION

The name of this Corporation shall be RENE M. DELOMBARD, P.A.

ARTICLE II PURPOSES

The general nature and purposes of business to be transacted, promoted and carried on by the . Corporation are to engage in the practice of law.

ARTICLE III CAPITAL STOCK

- A. The maximum number of shares of stock that the Corporation is authorized to have outstanding at any time shall be 10,000 shares of common stock having a par value of \$0.01 per share.
- B. The consideration to be paid for each share shall be payable in lawful money or property, labor or services.
- C. Shares of the Corporation's stock and certificates shall be issued only to lawyers in good standing and duly licensed and otherwise legally authorized within the State of Florida to render the same professional services as this Corporation.

ARTICLE IV EFFECTIVE DATE AND DURATION

The Corporation shall commence its existence at the time of the filing of theses Articles and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE V REGISTERED AGENT

ARTICLE X INDEMNIFICATION

The Cosporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

ARTICLE XI PREEMPTIVE RIGHTS

Every Stockholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VII BOARD OF DIRECTORS

The Corporation shall have an initial board of directors consisting of at least one person. The number of directors may be increased or decreased from time to time by a resolution of the majority of the stockholders but shall never be less than one. ARTICLE VIII PRINCIPAL OFFICE
