## FIRST AMENDMENT TO AMENDED AND RESTATED ARTICLES OF INCORPORATION OF DOCTORS HEALTHCARE PLANS, INC.

The Articles of Incorporation of Doctors Healthcare Plans. "The total number of shares of all classes of stock which the Corporation shall have authority to issue is (i) 90,000,000 shares of Class A Common Stock, \$0.01 par value per share ("Class A Common Stock"), (ii) 10,000,000 shares of Class B Common Stock, \$0.01 par value per share ("Class B Common Stock," and together with the Class A Common Stock, the "Common Stock"), and (iii) 20,092,593 shares of Preferred Stock, \$0.01 par value per share ("Preferred Stock")."

**THIRD:** The effective date and time of this Amendment shall be the date and time it is filed with the Division of Corporations of the Florida Department of State.

**FOURTH:** The Amended and Restated Articles of Incorporation shall remain in full force and effect except as expressly modified by this Amendment.
