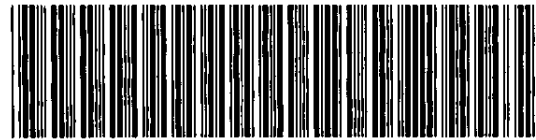

**ARTICLE I
NAME**

The name of the Corporation is SWACK DADDY'S, INC.

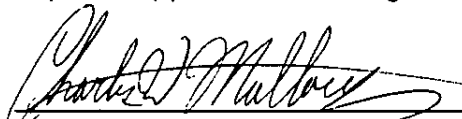

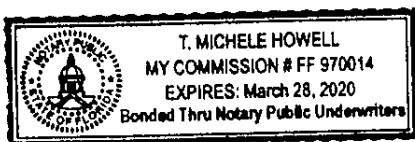
