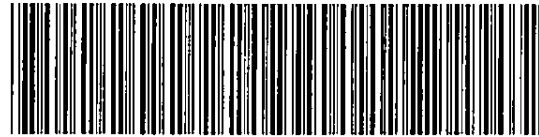

This corporation had filed a voluntary dissolution 4/24/18, and revoked its dissolution 6/22/18.


Somehow another dissolution was added 2 months later maybe possibly entered late by clerk later after

On or about May 4, 2023 corporate members called and spoke with sunbiz regarding the articles of dissolution in the file that were never intended to be entered on 8/22/18. Once members revoked their dissolution they did not check the sunbiz website, and having being locked out of previous emails did not receive any further emails from sunbiz to date. Members explained the whole situation in which a customer service agent told members to send a cover letter stating they had gotten approval / spoke to "Tammy" who is the amendment manager and that they would revoke the dissolution. Members were told to have a courier for expeditious purposes to bring in the cover letter along with a revocation of dissolution, which is what they did. Members do have many other corporations, however I do not know if this was a clerical error in entering a revocation on 8/22/18 or was intended for another corporation. Members are willing to sign necessary paperwork and pay fees to correct this and would pray this would be correctly expeditiously as members are trying to sort out many financial matters.
