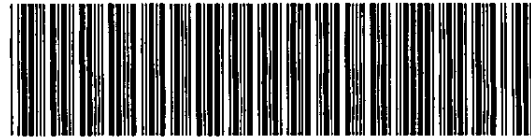


I have enclosed the form for the Articles of Incorporation for a new corporation.
