# ARTICLES OF INCORPORATION OF JAS HOLDCO, INC.

Pursuant to Florida Statutes Section 607.0201, the undersigned hereby submits the following Articles of Incorporation of JAS HOLDCO, INC., a corporation being organized under the laws of the State of Florida.

### ARTICLE I

The name of the Corporation is "JAS HOLDCO, INC." (hereinafter called the "Corporation").

## ARTICLE II Principal Address

The principal street address and mailing address of the Corporation is 3373 NW 107 Street, Miami, Florida 33167.

## ARTICLE III Shares

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 300 shares consisting of (a) thirty (30) shares of Series A Voting Common Stock, \$5.00 par value ("Voting Common Stock"), and (b) 270 shares of Series B Non-Voting Common Stock, \$5.00 par value ("Non-Voting Common Stock") and, together with the Voting Stock, the "Common Stock"). The holders of the Class B Non-Voting Common Stock shall have no right to vote on any matter. Other than the voting rights of the Voting Common Stock, both classes of Common Stock shall be identical.

### ARTICLE IV Registered Agent

The street address of the initial registered office of the Corporation is 1200 South Pine Island Road, Broward County, Plantation, Florida 33324. The name of the initial registered agent of the Corporation at that address is C T Corporation System.

#### ARTICLE V Incorporator
