ARTICLES OF INCORPORATION  
OF  
LEON HEALTH SYSTEMS, INC.

ARTICLE I - NAME

The name of this corporation is LEON HEALTH SYSTEMS, INC. (the "Corporation").

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business

ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue (i) 1,000 shares of voting common stock, with a par value of \$0.01 per share (the "Voting Common Stock"), and (ii) 99,000 shares of non-voting common stock, with a par value of \$0.01 per share (the "Non-Voting Common Stock"). The holders of the shares of the Voting Common Stock and the holders of the shares of the Non-Voting Common Stock shall have identical rights with respect to (i) distributions from the Corporation; (ii) the liquidation of the Corporation; and (iii) all other matters affecting the Corporation, except that (A) each holder of shares of the Voting Common Stock shall be entitled to one vote per each share of Voting Common Stock held by such holder on all matters required or permitted to be voted on by the Corporation's shareholders, and (B) no holder of shares of Non-Voting Common Stock shall have, by virtue of his/her/its ownership or holding of such shares of Non-Voting Common Stock, any voting rights whatsoever with respect to any matters required or permitted to be voted on by the Corporation's shareholders; provided, however, (1) that no amendment, restatement or modification of this Article IV that would have the effect of materially adversely affecting the economic rights of the holders of Non-Voting Common Stock (including, without limitation, their identical rights to distribution and liquidation proceeds as the holders of Voting Common Stock) may be effectuated without the prior written consent or affirmative vote of the holders of at least a majority of the outstanding shares of Voting Common Stock and Non-Voting Common Stock, voting together solely and exclusively for this purpose as

a single voting class, and (II) as may be otherwise specifically prohibited by the Florida Business Corporation Act."
