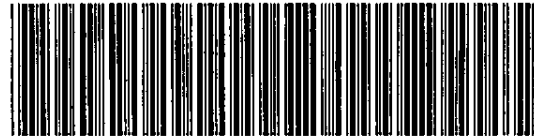

ARTICLES OF INCORPORATION OF SUMMER BAKER, P.A.

Organized under Chapters 607 and 621, Florida Statutes, For Profit.

ARTICLE I. NAME.

The name of this For Profit Corporation shall be Summer Baker, P.A., (the "Corporation") and it shall be formed as a Professional Association under Chapters 607 and 621, Florida Statutes.

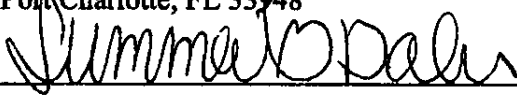
