Dear Help Department,

We obtained Electronic Filing Cover Sheet on 2/17/17, showing filing fee charge to our SunBiz account of \$70.00 (fax audit number H17000046452 3.

That same day we faxed in Articles of Incorporation with corporate name "AMS MANAGEMENT, INC.", with the electronic filing cover sheet.

We received a rejection letter dated Feb. 20, 2017 stating that corporate name was unavailable, and that we should select a new name and to forward the revised Articles with a copy of the letter and the electronic filing cover sheet

On 2/21/17 we faxed in Articles of Incorporation with the new name selected, which was "AMS MANAGEMENT OF BREVARD, INC". We also attached the rejection letter of Feb. 20, and a copy of the electronic filing cover sheet.

On Feb 22, we received another rejection letter, stating that the name on the cover sheet and article 1 did not match. Naturally it did not match, because we had to change the name.

In any event, on 2/22/17 we again faxed the Articles of Incorporation (with the corrected name), a copy of the electronic filing cover sheet, and copies of the two rejection letters.

On Feb. 23, 2017, we now received a THIRD rejection letter, stating "The entity name does not cover sheet, or Article header".

Again, naturally it does not match because we had to change the name, as originally directed in the first rejection letter.

Attached are copies of the Articles of Incorporation, the electronic cover sheet, and the three rejection letters.

Can you please see to it that the Articles are filed today, and that a letter of acknowledgement is faxed to us .

ARTICLE XIV: AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

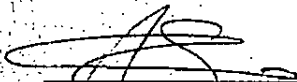
ARTICLE XV: I.R.C. SECTION 1244 STOCK

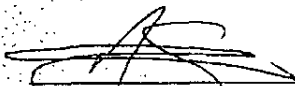
