ARTICLES OF INCORPORATION

These Articles of Incorporation are adopted for the purpose of forming a corporation under the laws of the State of Florida under Chapter 607 of the Florida Statutes, being the Florida Business Corporation Act, to be filed with the Florida Department of State, as follows:

ARTICLE ONE: NAME

The name of the corporation is HLA Fidu, Inc., and its principal office address is 3908 26th St W, Bradenton, FL 34205, until and unless such address is subsequently changed by the corporation.

ARTICLE TWO: COMMENCEMENT AND DURATION

The corporation shall commence its corporate existence as of 3 March 2017 and it shall exist perpetually thereafter until dissolved according to law.

ARTICLE THREE: PURPOSE

The corporation is organized for the primary purpose of providing fiduciary services as a trustee of land trusts established pursuant to the Florida Land Trust Act, §689.071 of the Florida Statutes (or the corresponding provisions of any succeeding law), as amended from time to time, including any and all ancillary or related activities, transactions, and business related thereto. Any and all real property, including any interest in real property, appearing to be owned by the corporation outright shall be deemed owned and held by the corporation in a fiduciary capacity as a trustee only, but conferred with the power and authority to protect, conserve, sell, lease, encumber, and otherwise manage and dispose of any and all such real property or any interest therein, pursuant to the Florida Land Trust Act and §689.073 of the Florida Statutes (or the corresponding provisions of any succeeding law), as amended from time to time.

No one dealing with the corporation shall be required to inquire as to the identification of the beneficiaries of any trust nor of the provisions or terms of any trust agreement. It shall be conclusively presumed that at the time of execution and delivery of any document by the corporation affecting any real property or any interest therein, a trust agreement was in full force and effect, such document was executed in full compliance therewith, and the corporation was duly authorized and empowered to execute and deliver such document.

The corporation shall have the authority to issue 100 shares of common stock with a par value of one penny per share.
