I understand Wills Murray Golf, Inc was administratively dissolved or revoked on September 23, 2016 due to failure to file a 2016 annual report.

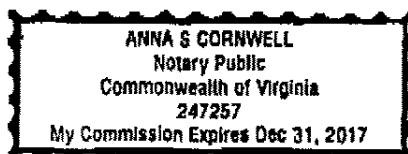
