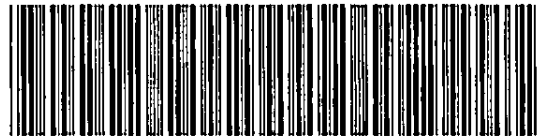

1. The name and jurisdiction of the surviving corporation is FIREBALL FIREWORKS, INC. a Florida corporation.


2. The name and jurisdiction of the merging corporation is ZIG ZAG FIREWORKS, INC., a Florida corporation.






