The undersigned, acting as incorporator of ABBSS, Inc., a Florida corporation, under the Florida Business Corporation Act, Florida Statutes Chapter 607, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

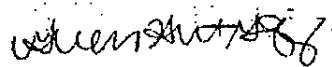
