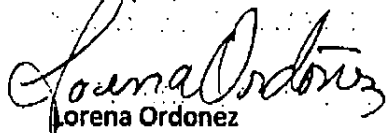

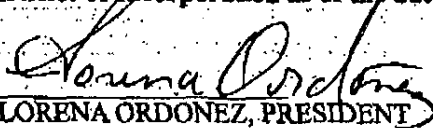
ARTICLE 10
