1. The name of this corporation is Royal Agio Cigars USA Inc., a Florida corporation (the "Corporation"), whose principal office address is 1812 44<sup>th</sup> Avenue East, Bradenton, Florida 34203.

2. The Articles of Incorporation of the Corporation, originally filed March 17, 2017, under Document No. P17000025086, are hereby deleted in their entirety and amended and restated to read as follows:

**ARTICLE I - NAME AND BUSINESS ADDRESS**

The name of this Corporation is Royal Agio Cigars USA Inc. Its principal office address and business mailing address is 1812 44<sup>th</sup> Avenue East, Bradenton, Florida 34203.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

**ARTICLE IV - CAPITAL STOCK**

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 10,000 shares of common stock, having a par value of \$0.001 per share.

**ARTICLE V  
REGISTERED OFFICE AND AGENT**

The street address of the registered office of this Corporation shall be 100 S. Ashley Drive, Suite 400, Tampa, Florida 33602, and the name of the initial registered agent at that address is CF

Registered Agent, Inc., a Florida corporation, who upon accepting this designation agrees to comply with the provisions of Chapters 48 and 607, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process.

#### **ARTICLE VI - BOARD OF DIRECTORS**

The number of directors may be increased or decreased from time to time by vote of the Board of Directors, but in no case shall the number of directors be less than one nor more than nine. The names and addresses of the directors constituting the Board of Directors are:


