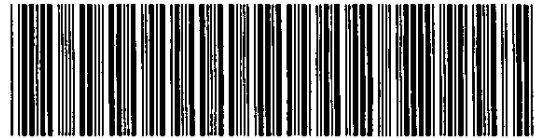

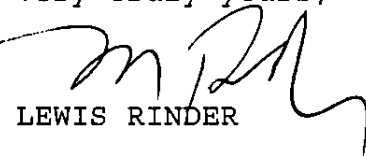

ARTICLES OF INCORPORATION  
OF  
BETTERJOB, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE - NAME

The name of this corporation shall be BETTERJOB, INC.

ARTICLE TWO - PRINCIPAL OFFICE

The street address of the initial principal office and the mailing address of this corporation is 632 S.E. Monterey Road, Stuart, Florida 34994.

ARTICLE THREE - PURPOSE

The general purpose for which this corporation is organized is to engage in or transact any and all lawfull business for which a corporation may be incorporated under the Florida General Corporation Act.

ARTICLE FOUR - SHARES

The aggregate number of shares which this corporation has authority to issue is TWENTY MILLION (20,000,000), all of which shall be one class of common shares with a par value of ONE TEN THOUSANDTH OF A DOLLAR (\$0.0001) per share, with full voting rights.

ARTICLE FIVE - INITIAL DIRECTORS

The term of existence of this corporation shall be perpetual and shall commence on the date the Articles of Incorporation are filed with the Department of State.

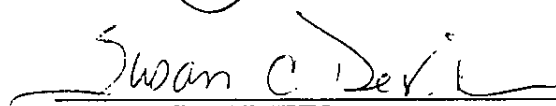
ARTICLE NINE - BYLAWS

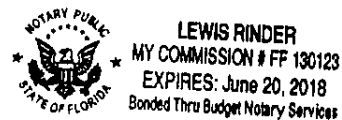

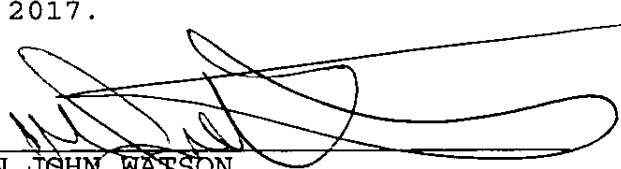
