ARTICLE I - NAME & ADDRESS

The name of this corporation is COMMERCIAL SPECIALTY INTERIORS, INC., and the address of the corporation is 3800 Liggett Street, Pensacola, FL 32505.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing upon the date of subscription and acknowledgment of these articles of incorporation.


