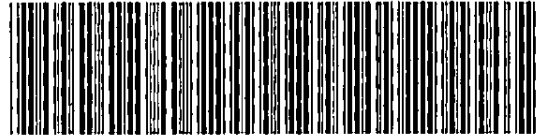

- If amending the name of the corporation, the new name must be distinguishable on the records of the Florida Department of State. You are responsible for any name infringement that may result from your corporate name selection.


