ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
FORZA ROMA CORPORATION

1. The name of this corporation is FORZA ROMA CORPORATION (the "Corporation").
2. Pursuant to the provisions of section 607.1006, Florida Statutes, Article IX of the Articles of Incorporation of FORZA ROMA CORPORATION, a Florida corporation, is hereby amended as follows:
