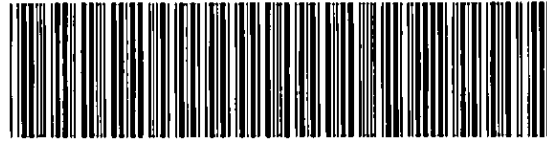

Payall Payment Systems, Inc. is a corporation organized under the laws of the State of Florida.

Pursuant to the provisions of Section 607.0124 of the Florida Business Corporation Act (the "FBCA"), the undersigned corporation executes the following Articles of Correction:

1. The name of the corporation is Payall Payment Systems, Inc. (the "Corporation").
2. The Amended and Restated Articles of Incorporation of the Corporation were filed with the Florida Department of State on October 7, 2021, and such document requires correction as permitted under the provisions of Section 607.0124 of the FBCA.
3. The inaccuracies in said document to be corrected are as follows:
  - Article IV, Section A, incorrectly states that all shares of the Corporation's "Series A Preferred stock previously authorized and issued by the Corporation are hereby redesignated as Series Seed Preferred Stock."
  - Article IV, Section C, incorrectly states that the "Original Issue Price of the Series Seed Preferred stock shall be one dollar and thirty-seven cents (\$1.37) per share."
4. The foregoing inaccuracies in the document are corrected to read as follows:
  - Article IV, Section A, shall state that all shares of the Corporation's "Series A Preferred stock previously authorized and issued by the Corporation are hereby redesignated and split into three (3) shares of Series Seed Preferred Stock."
  - Article IV, Section C, shall state that the "Original Issue Price of the Series Seed Preferred stock shall be \$1.7155601 per share."
