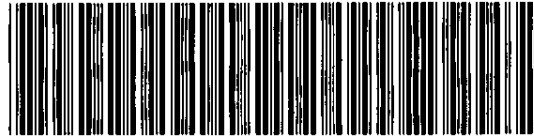

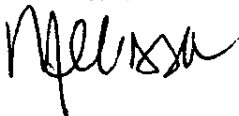

The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I
Name

The name of this corporation shall be: **SCG GRIMALDI, P.A.**

ARTICLE II
Principal Office and Mailing Address

The address of the principal office shall be 500 E. Kennedy Blvd., Suite 200, Tampa, FL 33602 and the mailing address of this corporation shall be 500 E. Kennedy Blvd., Suite 200, Tampa, FL 33602.

ARTICLE III
Duration and Purposes

The effective date of the formation of this corporation shall be April 24, 2017. The Company is formed for the purpose of conducting and undertaking, and shall have the power to conduct and undertake, activities and actions authorized under the Florida Business Corporation Act, Chapter 607 and the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes. 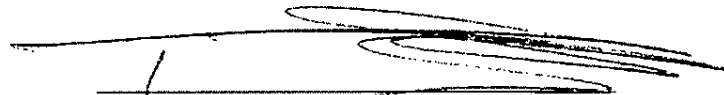
