
I am an attorney assisting a client with incorporating the above-referenced profit corporation. According to an email sent from the New Filing Section, the Articles of Incorporation were not filed because:

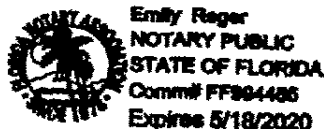




