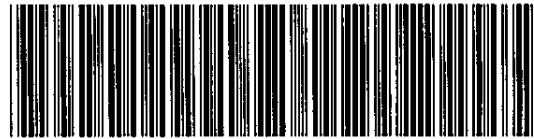



ARTICLE I. NAME

The name of this corporation is TAYLOR'S TIMELY TURNAROUND INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE






