ARTICLES OF INCORPORATION
OF
CLIFTON HOSPITALITY, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Clifton Hospitality, Inc. and its address is 7542 Trento Circle, Naples, Florida 34113.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSE

The general purposes for which the corporation is organized are:




