#### ARTICLES OF INCORPORATION

OF

#### SMITHBUILT CONTRACTING INC.

#### ARTICLE I - NAME

The name of the corporation is Smithbuilt Contracting Inc., at 1175 San Juan Drive, Merritt Island, FL 32952 (Principal Office of Registered Agent).

## **ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

#### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.

## ARTICLE IV - CAPITAL STOCK
