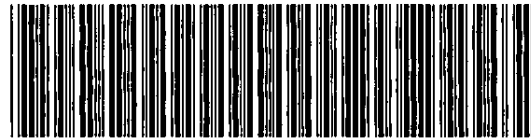



ARTICLES OF INCORPORATION

OF

DBDG INTERNATIONAL, INC.

ARTICLE I

NAME

The name of the corporation shall DBDG International, Inc. ("Corporation").




