Attachment to Certificate of Incorporation of Inka Security Solutions, Inc.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 1,200,000 of which 1,000,000 shares of par value \$0.001 per share shall be designated as Common Stock and 200,000 shares of par value \$0.001 shall be designated as Preferred Stock.
