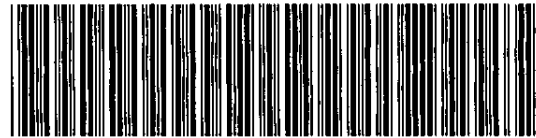

Article IV. The corporation shall be authorized to issue One Thousand (1,000) shares of common stock, Class A, with a par value of One Dollar (\$1.00) per share.


