

**ARTICLES OF INCORPORATION  
OF

The undersigned, being of the age of eighteen years or more, do hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of Florida as contained in Chapter 607 or 621 of the Florida Statute.

**ARTICLE I**

The name of the corporation is Stepa, Inc.

The number of directors of the corporation may be fixed by the bylaws, but shall not be less than the minimum number allowed by the "Florida Business Corporation Act."


