

ARTICLES OF AMENDMENT

OF

H.I.D. INTERNATIONAL, INC.

WHEREAS, H.I.D. INTERNATIONAL, INC., document number P17000049659, is a duly organized profit corporation existing under the laws of the State of Florida, and

WHEREAS, the Shareholders of H.I.D. INTERNATIONAL, INC. by resolution unanimously adopted on the 13 day of ______, 2017, have resolved to make certain changes in the Articles of Incorporation and hereby show and manifest our intention that the Articles of Incorporation be altered and amended by deleting Articles IV and V therefrom and substituting in lieu thereof the following provisions:

ARTICLE IV

CAPITAL STOCK: The Corporation shall be authorized to issue up to One Hundred Thousand (100,000) shares of capital stock in the Corporation representing one class of shares, having a par value of One Dollar (\$1.00) per share. Any stock issued shall be fully paid upon its issue and non-assessable. Any of such stock may be transferred and sold in whole or fractional shares. There shall be included in the Bylaws of the Corporation provisions recognizing preemptive rights of stockholders and limitations of the issue and transfer of stock in violation of rights or agreements of the stockholders. The stockholders may include in their agreements among themselves or with the Corporation limitations on the transferability and agreements for preemptive rights of purchase with reference to such stock, or any part thereof, whether issued or to be issued, or options to purchase in the event of sale or pledge of stock issued by the Corporation.

INITIAL CAPITAL: The amount of the capital with which this Corporation will begin business shall not be less than the sum of Ten Thousand (\$10,000.00) Dollars.
