The undersigned, for the purpose of forming a corporation under the Florida
General Corporation Act do hereby adopt the following articles of incorporation:

ARTICLE I

The name of this Corporation is: SUNDAY MORNING KEIKO, INC.

ARTICLE II

NATURE OF BUSINESS: The general nature of the business is a community to
facilitate the dissemination of Martial Art information and technique.

To carry on such other business or activities as may be necessary, convenient
or desirable to accomplish the above purposes, and to do all other things incidental
thereto which are not prohibited by law or by these Articles of Incorporation.


ARTICLE VIII


