ARTICLES OF INCORPORATION
OF
MITCHELL S. HALPERIN, M.D., P.A.

I, THE UNDERSIGNED, HEREBY ORGANIZE FOR THE PURPOSE OF BECOMING A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA, BY AND UNDER THE PROVISIONS OF THE STATUTES OF THE SAID STATE OF FLORIDA, PROVIDING FOR THE FORMATION, RIGHTS, PRIVILEGES, IMMUNITIES, AND LIABILITIES OF CORPORATIONS FOR PROFIT.

ARTICLE I - NAME AND PRINCIPAL OFFICE

THE NAME OF THE CORPORATION SHALL BE:

ARTICLE II - DURATION

THIS CORPORATION SHALL EXIST PERPETUALLY, COMMENCING ON THE DATE OF EXECUTION AND ACKNOWLEDGEMENT OF THESE ARTICLES.

ARTICLE III - PURPOSE

THIS CORPORATION IS FORMED TO ENGAGE IN EVERY ASPECT OF THE PRACTICE OF MEDICINE AND TO ENGAGE AND RENDER THE PROFESSIONAL SERVICE INVOLVED ONLY THROUGH ITS OFFICERS, AGENTS, AND EMPLOYEES WHO ARE DOCTORS OF MEDICINE IN GOOD STANDING AND DULY LICENSED WITHIN THE STATE OF FLORIDA. IN ADDITION, THE CORPORATION MAY INVEST ITS FUNDS IN REAL ESTATE, MORTGAGES, STOCKS, BONDS, AND ANY OTHER TYPE OF INVESTMENTS PERMITTED BY LAW, AND THE CORPORATION MAY OWN REAL AND PERSONAL PROPERTY NECESSARY FOR THE RENDERING OF PROFESSIONAL SERVICES.

ARTICLE IV - CAPITAL STOCK

THE CORPORATION IS AUTHORIZED TO ISSUE 7,000 SHARES OF \$1.00 PAR VALUE COMMON STOCK, WHICH SHOULD BE DESIGNATED "COMMON SHARES."

ARTICLE V - CAPITAL

ARTICLE XV - RESTRICTIONS ON TRANSFER OF STOCK




