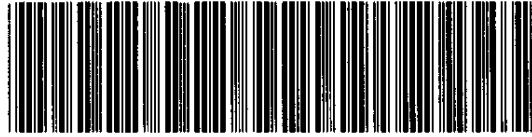

**ARTICLES OF INCORPORATION  
OF

**ARTICLE I  
NAME**

The name of the Corporation is: SF Transaction Holdings, Inc.

**ARTICLE II
