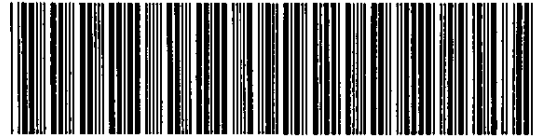

The undersigned incorporator hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I NAME**

The name of this corporation is ENCLAVE SERVICES, INC.

**ARTICLE II ADDRESS**
