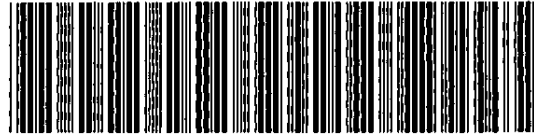

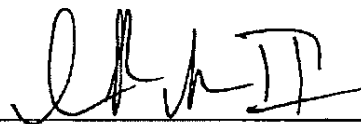
ARTICLE X

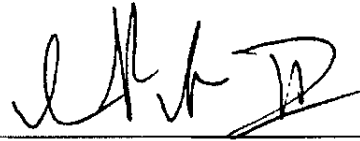
