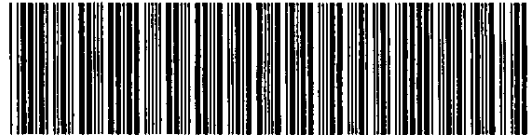



The undersigned acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I - NAME & ADDRESS

The name of this corporation is **TENNISWOOD, INC.** and the address of the corporation is 308 South Jefferson Street, Pensacola, Florida 32502.

This corporation shall exist perpetually, commencing upon the date of subscription and acknowledgment of these articles of incorporation.






