The undersigned, for the purpose of forming a professional association under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE - NAME

The corporate name shall be: ILEANA RODICIO, M.D., P.A.

ARTICLE TWO - CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE THREE - PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

- 1. In general for the purpose of rendering medical professional service to the public, to promote the interests of the professional association in its activities, and to enhance its value.
- 2. To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease, or otherwise dispose of real and personal property, including franchises, websites, patents, blogs, copyrights, trademarks, and licenses in the State of Florida, and in all other states and countries.
- 3. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes, and other evidence of indebtedness, and execute such mortgages, transfers of corporate property, or other instruments to secure the payments of corporate indebtedness as required.
- 4. To purchase the assets of any other professional association and engage in the same character of business.
- 5. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE FOUR - CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is 10. Such shares shall be of a single class, and shall have no par value.

ARTICLE FIVE - REGISTERED AGENT; PRINCIPAL OFFICE

The registered agent shall be Ileana Rodicio, M.D., and the street address of the professional association's registered office is 3902 SW 144 Avenue, in Miami, Florida 33175

ARTICLE SIX - DIRECTORS

The number of directors constituting the initial board of directors of the professional association is one, and shall never be less than one. ARTICLE SEVEN - INCORPORATORS

The professional association shall indemnify any officer or director or any former officer or director to the full extent permitted by law.

This professional association reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.
