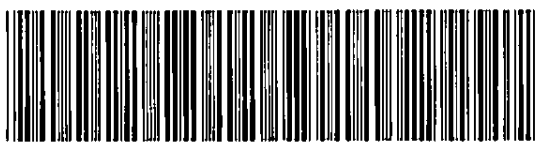

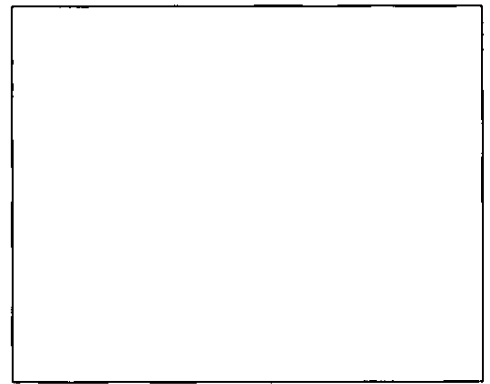

**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendment to its Articles of Incorporation:

1. The current name of the corporation is FINANCE AMERICA MORTGAGE, INC. (the "Corporation").
