My name is Thomas Schrade, I am the owner of TOGIOL-INC in Naples, FL.

As a registered agent for me was so far the company

I have terminated the contract with MYUSCORP in due time at the end of the year 2022 and have reoriented myself. As of 01/01/2023 I was represented by BRANDON TYLER CONSULTING INC, Matthias Dolatowski at my own request, after paying my invoice my new partner executed the corresponding Annual Report on my behalf. This was on March 27th 2023.

Today, my new Registered Agent informed me that he happened to find out that my company was voluntarily closed down on April 2nd, 2023, while checking the company register at the Department of State. The public documents show that my signature was used for this purpose.

I declare under oath that I have never intended to close the company Togiol Inc, nor have I instructed anyone to do so, nor have I allowed anyone to use my electronic signature for this act.

I hereby file a complaint against unknown persons for fraud, business damage, forgery of documents and forgery of signatures.

Please inform me as soon as possible how I can undo this criminal act so that I can continue my business unhindered.

Since I cannot be on site myself, I request that you also provide information to my Registered Agent, here Matthias Dolatowski *May 14th 1961, giving him the Power of Attourney so that he can inform me about the progress of the investigation.
