**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of Mark Bruce South, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is Mark Bruce South, Inc. (the "Corporation").

The name and street address of the incorporator is Mark Rosen, 11380 Prosperity Farms Road, #221E, Palm Beach Gardens, FL 33410.


ARTICLE IX. BYLAWS
