**ARTICLE II
CORPORATE EXISTENCE**

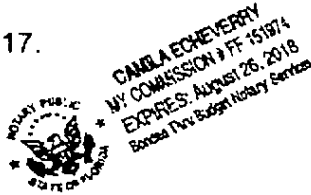


