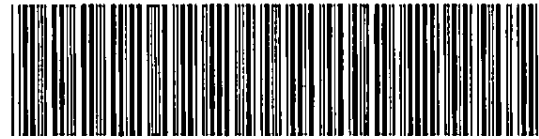

**FINAL JUDGMENT OF DISSOLUTION
OF MARRIAGE**

THIS CAUSE having come on for Final Hearing on October 22, 2018 and after an Answer having been filed by the Respondent, and the Court having heard testimony of the Petitioner and the Petitioner showing proof that he is a resident of the State of Florida, and being otherwise advised in the premises, makes the following findings:

- A. The Court has jurisdiction of the parties and subject matter.
- B. The marriage of the parties is irretrievably broken.
- C. There are no minor children born of the marriage and none are contemplated.
- D. The Petitioner has been a bona fide resident of Florida for more than six (6) months prior to the filing of this petition.
- E. The parties voluntarily entered into a Mediated Settlement Agreement dated August 29, 2018 wherein the rights and responsibilities that have arisen as a result of the marriage are defined.

F. The Petitioner's maiden name shall be restored to: Millie Tejera.

WHEREFORE it is ORDERED AND ADJUDGED that:

1. That the marriage of the parties is dissolved and each spouse

is restored to the status of being single and unmarried.

2. That this Court reserves jurisdiction of the parties and subject matter for purposes of enforcement of the Mediated Settlement Agreement dated August 29, 2018.

3. The provisions set forth in the Mediated Settlement Agreement dated August 29, 2018 executed by the parties shall be binding and enforceable. The Mediated Settlement Agreement dated August 29, 2018 be incorporated as part of this Judgment.

4. The Petitioner's maiden name shall be restored to: Millie Tejera.
