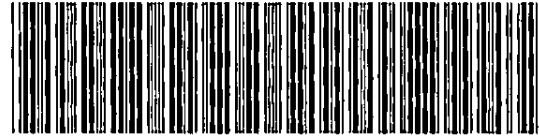

**ARTICLE I**

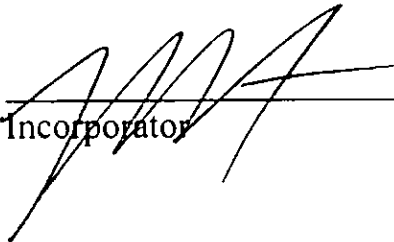

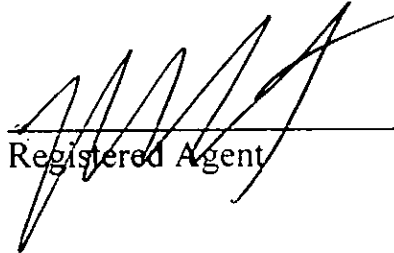
