**ARTICLES OF INCORPORATION

The undersigned, licensed or otherwise legally authorized to practice medicine by and within the State of Florida, hereby acting as incorporators for the purpose of forming a professional service corporation for profit, by virtue of the provisions of Chapters 621 and 607, Florida Statutes, do hereby adopt the following Articles of Incorporation:

ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Corporation is: JESUS NAVARRO, P.A., and its principal office or mailing address is 4710 N. Habana Ave., #300, Tampa, FL 33614.

ARTICLE 2: DURATION

This Corporation shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of Florida.

ARTICLE 3: PURPOSE

This Corporation is organized for the following purposes:

- (a) To engage in every aspect of the practice of medicine and all of its fields of specialization as are engaged in by Doctors in this state.

ARTICLE 4: CAPITAL STOCK
