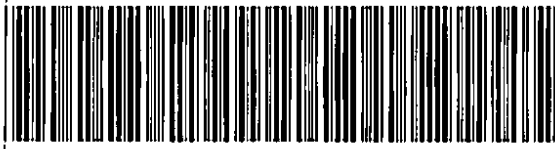

Pursuant to the authority of §607.1005 of the Florida Business Corporation Act, the undersigned corporation, **GULFSTREAM LOGISTICS, INC.** (the "Corporation"), hereby adopts and files the following Articles of Amendment to its currently existing Articles of Incorporation:

(1) ARTICLE FIRST: The name of the Corporation is presently "GULFSTREAM LOGISTICS, INC."

(2) ARTICLE SECOND: Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety, and is hereby replaced and superseded by the following replacement Article I:

**ARTICLE I  
NAME OF CORPORATION**

The name of the corporation is GULFSTREAM LOGISTIC SERVICES, INC.

(3) ARTICLE THIRD: The foregoing amendment to the Articles of Incorporation of the Corporation was adopted by written consent of the sole incorporator of the Corporation as of and effective the 27<sup>th</sup> day of July, 2017, and such consent is sufficient for approval of such amendment. As of the date hereof and of such consent of the sole incorporator, no shares of the capital stock of the Corporation have been issued.
