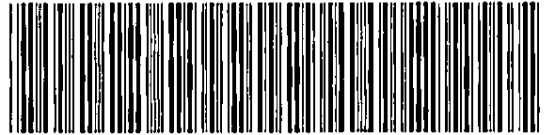

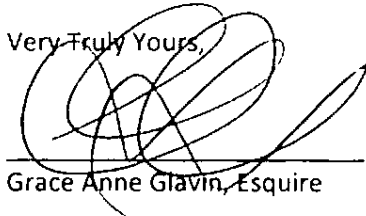

FOR
BARKINGHAM PALACE NORTH, INC.

The undersigned, acting as incorporators for this business corporation pursuant to Chapter 607 of the Florida Statutes, hereby form a Business Corporation under the laws of the State of Florida and adopt the following Articles of Incorporation for such corporation.

ARTICLE I
NAME OF CORPORATION

The name of the corporation shall be **BARKINGHAM PALACE NORTH, INC.**

ARTICLE II
TERM OF EXISTENCE

This corporation shall begin its corporate existence as of the ^(25th) 28th day of July, 2017, and shall exist perpetually.

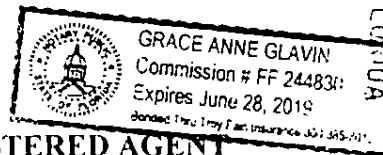
