ARTICLES OF INCORPORATION

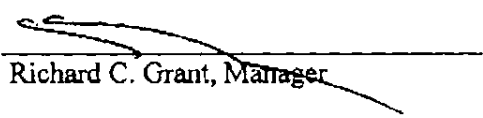
**CERTIFICATE OF DESIGNATION OF
