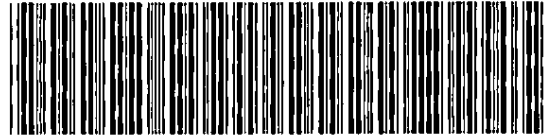

This letter is to explain the facts and circumstances surrounding the creation of Tenex, LLC.

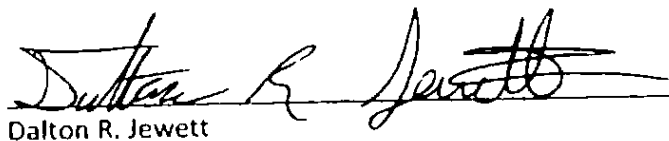
