ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation, being a doctor of optometry duly licensed to render optometry services as such under the laws of the State of Florida, hereby presents these Articles for the formation of a corporation under Chapter 621, Professional Service Corporation and Limited Liability Company Act, and other laws of the State of Florida.

The name of the Corporation is DOUGLAS REYNOLDS, O.D. Name. 1. SANTA ROSA, P.A. (the "Corporation").

Nature of Business. The general nature of the business to be transacted by 2. the Corporation is:

(a) To engage in every phase and aspect of the business of rendering optometry services to the public that a doctor of optometry duly licensed under the laws of the State of Florida, is authorized to render, provided such optometry services shall be rendered only through officers, employees, and agents who are duly licensed or otherwise legally authorized under the laws of the State of Florida to render such services.

To invest the funds of the Corporation in real estate, leases, (b) mortgages, stocks, bonds, or any other type of investments, and to own real and personal property necessary for the rendering of professional services.

(c) To do everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Incorporation or any amendment thereof, necessary or incidental to the protection and benefit of the Corporation, and in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes or the attainment of the objects or the furtherance of such purposes or objects of the Corporation.

The foregoing paragraphs shall be construed as enumerating both objects and purposes of the Corporation; and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of the Corporation otherwise permitted by law.

The aggregate number of shares of stock that this 3. Capital Stock. Corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock, having a par value of \$1.00 per share. None of the shares of the Corporation may be issued to anyone other than an individual duly licensed to render optometry services in the State of Florida.

No shareholder of a corporation organized under this act shall enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of that person's stock.
