

#### ARTICLES OF INCORPORATION

The undersigned, for the purpose of creating a professional service corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

## ARTICLE ONE CORPORATE NAME AND PRINCIPAL OFFICE

The name of the corporation is CHRISTINA KILPATRICK, P.A. ("Corporation") and its principal office and mailing address is 4081 Indian Bayou N, Destin, FL 32541.

#### ARTICLE TWO **NATURE OF BUSINESS**

The nature of the business to be transacted by the Corporation shall be to engage in every aspect in the practice of cosmetology and all its related fields and specializations, as are engaged in by CHRISTINA R. KILPATRICK. The professional services rendered by the Corporation may be rendered only through individuals duly licensed to render professional cosmetology services under the laws of the State of Florida. The Corporation shall not engage in any business other than the rendition of the professional cosmetology services specified herein. However, the Corporation may invest its funds in real estate, mortgages, stocks, bonds or any other type of investment and may own or lease real and personal property necessary for the rendering of the specified professional cosmetology services.

The common stock of the Corporation may not be issued to anyone other than an individual who is duly licensed to render professional cosmetology services. No shareholder of the Corporation shall enter into a voting trust agreement or other type of agreement vesting any other (H17000209580 3)

person with the authority to exercise the voting power of any or all of his/her shares of common stock of the Corporation.

## ARTICLE THREE **CAPITAL STOCK**

The Corporation is authorized to issue One Thousand (1,000) shares of stock with a par value of one dollar (\$1.00) each. Such stock shall be of a single class.

## ARTICLE FOUR TERM OF EXISTENCE

This Corporation shall have perpetual existence commencing upon the day of filing.

#### ARTICLE FIVE REGISTERED AGENT AND INITIAL REGISTERED OFFICE
